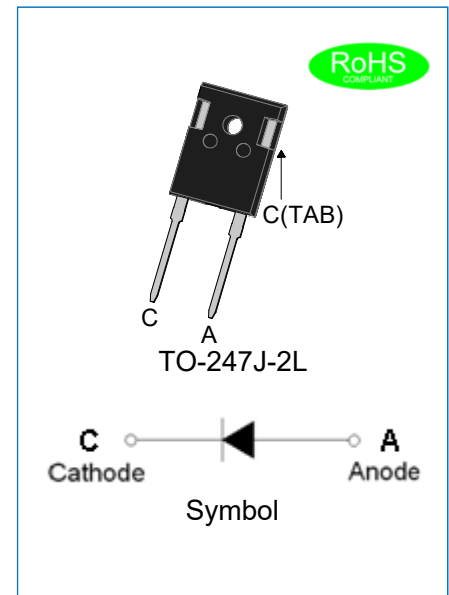

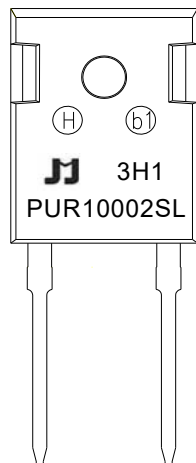

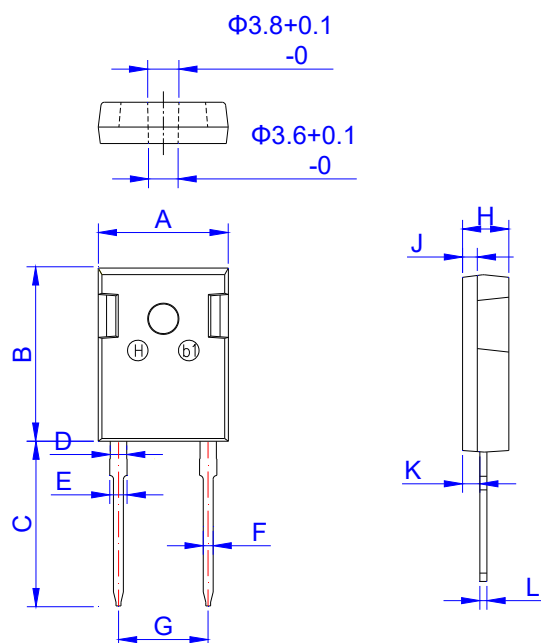

FIG.1 Typical forward characteristics

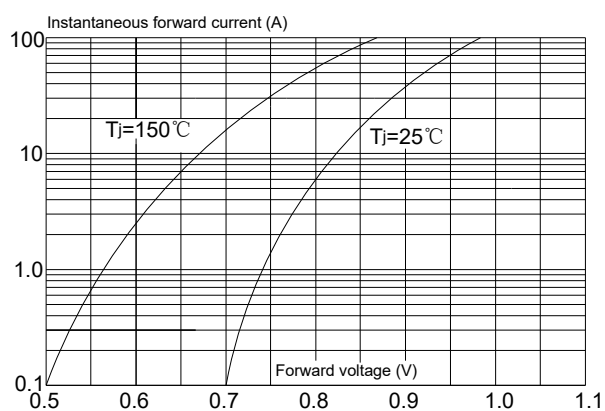


FIG.2 Typical reverse characteristics

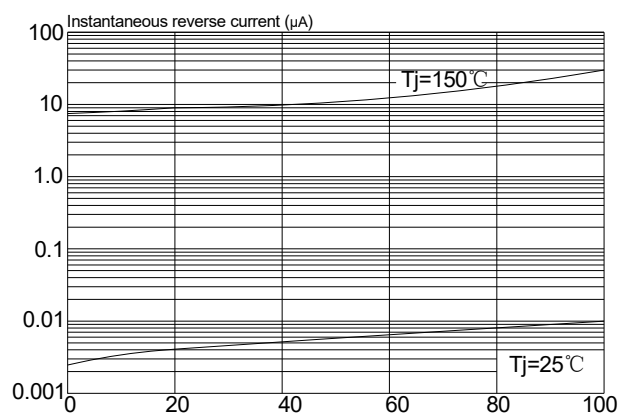


FIG.3 Maximum non-repetitive peak forward surge current(10ms single half sine-wave)

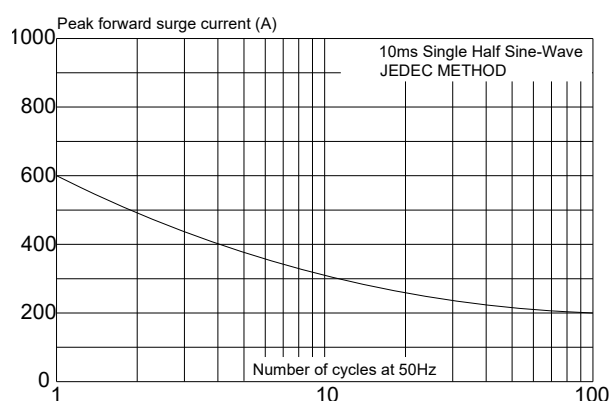


FIG.4: Forward current derating curve

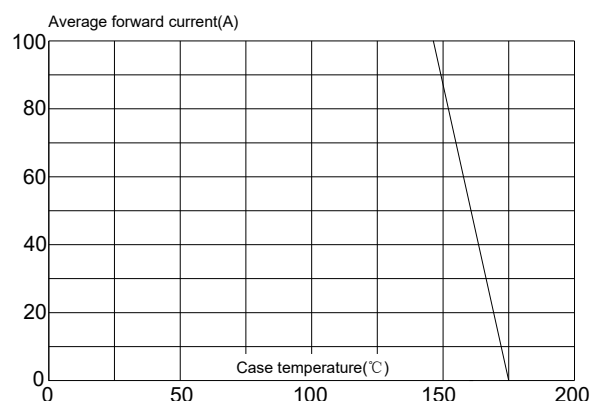
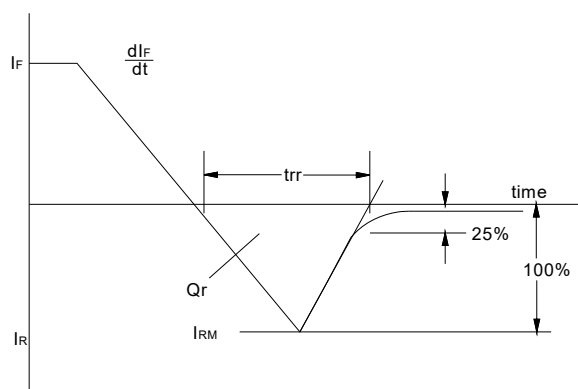


FIG.5: Reverse recovery definitions
